**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
EXTENDING THE STATE OF EMERGENCY IN NASSAU COUNTY, FLORIDA
DUE TO COVID-19**

WHEREAS, the Board of County Commissioners exercised its authority under Chapter 252.38(3), Florida Statutes; and

WHEREAS, Chapter 252.38(3)(5) provides that the duration of the state of emergency declared locally is seven (7) days; and


WHEREAS, the seven (7) day increment may be extended by a majority vote of the Board of County Commissioners of Nassau County, Florida; and

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, this 4th day of January, 2021 as follows:





